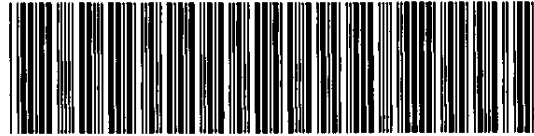

ARTICLES OF AMENDMENT OF
