**ARTICLES OF AMENDMENT TO
CONTOUR NAILS BY FANIT PANOFSKY, INC.**

Pursuant to the provisions of Section 607, Florida Statutes, this corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The Articles of Incorporation were filed on December 27, 1982. The assigned document number is G15307.

2. The Articles of Incorporation are amended as follows:

CAPITAL STOCK


The number of shares which the Corporation shall have authority to issue is five thousand (10,000) shares of common stock which shall consist of voting and non-voting shares.

- (a) Five thousand (5,000) of the authorized shares shall be designated as voting common stock with a par value of one cent (\$0.01).
- (b) Five thousand (5,000) shares shall be designated as non-voting common stock with a par value of one cent (\$0.01).

3. This Amendment was adopted on the 20th of September 2007.

4. The Amendment was adopted at a joint meeting of the Shareholders and Directors by a majority vote of the shareholders and directors to amend the Articles of Incorporation, as set forth in the By-Laws. The number of votes cast for the Amendment was sufficient for approval.
