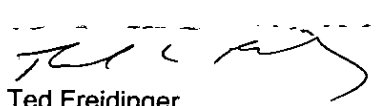
I called and was told that under the circumstances, we should place a hold on the original check and file the second notice (enclosed) with a check in the amount of \$150 with explanation.
