TO THE ARTICLES OF INCORPORATION OF

In accordance with Section 607.1006, Florida Statutes, the undersigned being the President of PAUL WAND, M.D., P.A., a Florida professional corporation (the "Corporation") does hereby execute these Articles of Amendment to the Articles of Incorporation of the Corporation.

1. Article I of the Corporation's Articles of Incorporation shall be deleted in its entirety and a new Article I shall be as follows:

2. Article II of the Corporation's Articles of Incorporation shall be deleted in its entirety and a new Article II shall be as follows:
