## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

### TAEKWONDO PLUS OF PENSACOLA, INC.

Pursuant to the provisions of Florida Statutes section 607.1006, this Florida profit corporation adopts these Articles of Amendment to its Articles of Incorporation.

FIRST: Amendments adopted: Article I of the Articles of Incorporation of Taekwondo Plus

of Pensacola, Inc. is hereby amended and restated to provide in its entirety as follows:

#### ARTICLE I

The name of the corporation is Pensacola Taekwondo Academy, Inc. The street address of the corporation's principal office is 33789 Southridge Road, Sioux City, IA 51104.

SECOND: Date of adoption: The foregoing amendment was adopted 1/20/2000.

THIRD: Method of adoption: The foregoing amendment was unanimously adopted by resolution of the Corporation's Board of Directors on 1/20/2000, and thereafter approved by sufficient vote of each voting group of the shareholders at a special meeting of the shareholders held on Jan. 20, 2000. The shares of all of the common stock of the corporation, representing the only voting group required to vote on the foregoing amendment, voted unanimously for approval of the foregoing amendment.
