On October 23, 1997 we had occasion to talk with, first, Robin and, afterward, with Andy concerning the filling of our 1997 Corporation Annual Report.

We explained to these two gentlemen that we had not received any documents from the Florida Department of State for this filling, hence, the purpose of our telephone inquiry of October 23, 1997. For that matter we have not received any documents related to the Annual Report at the time of this writing.

Both Robin and Andy were helpful and it was suggested we should file an Application for Reinstatement, the form for which we are submitting with this letter.

In prior years Fausto's Auto Exclusive, Inc has submitted its Annual Report filling in a timely fashion. This year's tardiness is a result of non-receipt of the forms from your office.
