Pursuant my telephone call of this morning, enclosed please find copies of documents as received from your office.

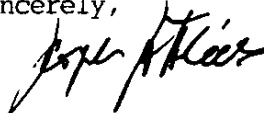
On July first week I received a post card (copy enclosed) stating that an ANNUAL REPORT was not filed, NOTICE OF INTENT TO DISSOLVE.
