I handle and administrate the accounting for their companies as follows: The Curtis Group, Inc., Westover Reserve, Inc., Paul Curtis Properties on behalf of Lake Sherwood hills, Inc., and Paul Curtis Realty, Inc. I began my employment here in July of 1998 and found that the bookkeeping system was in total disarray. I did not find any record where we received the first notice for filing of the corporations. It seems that my predecessor did not, among other things, complete the following:

- File any of the required tax returns
- Balance any of the bank accounts
- Enter any of the appropriate data into the accounting programs in order to complete regular returns to various governmental agencies

The list of incomplete tasks and erroneous data in need of research and correction has been endless.
