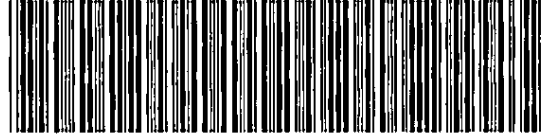



Article I of the Articles of Incorporation are amended as follows:


Name of Corporation: The name of the Corporation shall be GER-BOB, INC.
