Pursuant to the requirements of Florida Statutes, Sections 607.1003 and 607.1006, the undersigned does hereby make, swear to, adopt and file this Amendment to Articles of Incorporation of ATLANTIC BUILDERS, INC. (the "Corporation"), which Corporation was incorporated in the State of Florida on February 7, 1983.

1. The sole shareholder of the Corporation has approved a change in the name of the Corporation. Therefore, Article I of the Articles of Incorporation shall be deleted in its entirety and, in lieu thereof, there shall be substituted the following:
