ARTICLES OF DISSOLUTION*of***KAJENTO ENTERPRISES, INC.**

Pursuant to Section 607.1403, Florida Statutes, **Kajento Enterprises, Inc.**, a Florida corporation (the "**Corporation**"), submits the following Articles of Dissolution:

ARTICLE I

The name of the corporation is **Kajento Enterprises, Inc.** The document number for the Corporation is 'G24676.

ARTICLE II

The voluntary dissolution of the Corporation is authorized as of December 23, 2016.

ARTICLE III

The dissolution of the Corporation was approved by the shareholders of the Corporation holding a majority of the issued and outstanding stock of the Corporation entitled to vote.


ARTICLE IV

NOTICE OF DISSOLUTION
OF
KAJENTO ENTERPRISES, INC.

This Notice of Dissolution is submitted by **Kajento Enterprises, Inc.**, a Florida corporation (the "**Corporation**"), for resolution of payment of unknown claims against the Corporation as provided in Section 607.1407, Florida Statutes.

ARTICLE I

The name of the Corporation is **Kajento Enterprises, Inc.**

ARTICLE II

The effective date of the voluntary dissolution, as specified in the Articles of Dissolution filed with the Florida Department of State, is December 23, 2016.

ARTICLE III

Claims against the Corporation should be submitted to the address listed below. The following information must be included in each claim:
