Pursuant to the provisions of Section 607.1006, Florida Statutes, GAZEBO LANDSCAPE DESIGN, INC., a Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Articles 8, 9 and 10 of the Corporation's Articles of Incorporation are hereby deleted in their entirety:

SECOND: Article 11 of the Corporation's Articles of Incorporation is hereby renumbered to hereafter be Article 8 of the Corporation's Articles of Incorporation.

THIRD: The foregoing amendments were adopted on February 10, 1997.

FOURTH: The foregoing amendments were approved by the shareholders of the Corporation. The number of votes cast for the amendments were sufficient for approval. There were no voting groups entitled to vote separately on the amendments.
