**ARTICLES OF AMENDMENT TO
THE ARTICLES OF AMENDMENT AND RESTATEMENT OF
THE ARTICLES OF INCORPORATION OF
FLETCHER'S MEDICAL SUPPLIES, INC.**

A. The name of the company is Fletcher's Medical Supplies, Inc. (the "Corporation").

B. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on March 8, 1983 and assigned Document Number G26788. Articles of Amendment and Restatement were filed on December 31, 2012.

C. The shareholders of the Corporation unanimously approved an amendment to the Articles of Amendment and Restatement on September 28, 2021 to update the principal and mailing addresses of the Corporation and to amend Article II to read as follows:

"ARTICLE II – PRINCIPAL OFFICE


The street address of the principal place of business and the mailing address of this Corporation are 220 W. Germantown Pike, Suite 250, Plymouth Meeting, PA 19462."
