PLAN OF LIQUIDATION AND DISSOLUTION

The following constitutes a Plan of Liquidation and Dissolution of Owensboro Coal Dock, Inc. (the "Corporation"), a Florida corporation.

- 1. Attached to this Plan is a balance sheet of the Corporation as of March 31, 2000, with the Corporation's fixed assets valued at their appraised fair market value as of March 31, 2000. The balance sheet indicates that the Corporation's liabilities exceed its assets.
- 2. The Corporation has only one creditor, namely Alley-Cassetty Coal Company, to which the Corporation owes the sum of \$440,298 (the "Debt"). The Corporation will convey all of its current and fixed assets at or above their appraised value, according to the appraisal by an independent appraiser in exchange for a discharge of any further liability or obligation on account of the Debt.
- 3. Upon such distribution, the Corporation will proceed to dissolve under Florida law. Given that the Corporation will have no assets after payment of its liabilities, the shares held by the Corporation's preferred and common shareholders will be cancelled for no consideration.
- 4. The liquidation of the Corporation for tax and business purposes and the dissolution of the Corporation under Florida corporate law will be completed on or before April 28, 2000.
