Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of Deco Truss Company, Inc., a Florida for profit corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Deco Truss Company, Inc.

SECOND: The Articles of Incorporation of the Corporation are hereby amended by deleting the Article One thereof as it now exists and inserting in lieu thereof a new Article One, reading as follows:
