**ARTICLES OF AMENDMENT AND RESTATEMENT OF
THE ARTICLES OF INCORPORATION OF

- A. The name of the corporation is Rib, Inc. (the "Corporation").
- B. The Articles of Incorporation were filed with the Florida Secretary of State on March 25, 1983, and assigned Document Number G30397.
- C. Amendments to the Articles of Incorporation were adopted on May 12, 2016, by the sole shareholder and the sole member of the Board of Directors of the Corporation in order to amend and restate the Articles of Incorporation in their entirety to read as follows:

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of this Corporation is Rib, Inc.


