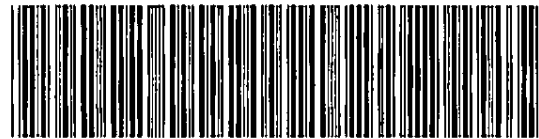

Adequate provision has been made for the debts, obligations and liabilities.

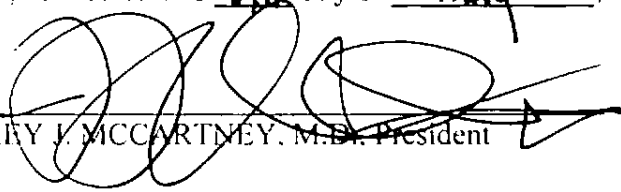
### ARTICLE VI – REMAINING PROPERTY AND ASSETS
