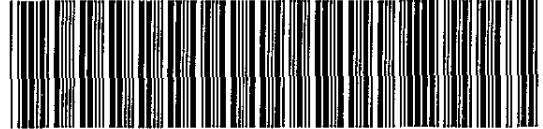

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Corporation adopts the following articles of amendment to its Articles of Incorporation:

1. The name of the Corporation is NATIONAL MEDICINE CENTER – HAINES CITY, INC.
2. Article VI of the Articles of Incorporation is hereby deleted in its entirety.
3.
