ARTICLES OF AMENDMENT

1. The following provisions of the Articles of Incorporation of **WM. A. INSKEEP & CO.**, a Florida corporation, filed in Tallahassee on April 1, 1983 (effective as of March 29, 1983), be and they hereby are amended in the following particulars:

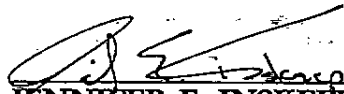
ARTICLE I - NAME AND CORPORATE EXISTENCE
