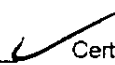



Nature of Corporate Business
