ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF DATALINK CORPORATION

FILED 99 MAR 12 PM 2: 07

THESE ARTICLES OF AMENDMENT are made to the Articles of Incompration and DATALINK CORPORATION, a Florida Corporation filed May 6, 1983 effective April 29, 1983 under charter number G37304, as follows:

- 1. Name of Corporation. The name of the Corporation is DATALINK CORPORATION.
- 2. <u>Shareholders. Officers and Directors.</u> The sole shareholder of the corporation is Cynthia Taylor. The sole officer and director of the corporation is Marvin C. Taylor.
- 3. <u>Text of Amendment.</u> Article III of the original Articles of Incorporation is deleted and the following is inserted in its place:

ARTICLE III

The maximum number of shares of stock which may be issued by the corporation shall be one million (1,000,000), which shall be common stock having no par value.

- 4. <u>Date adopted.</u> The foregoing Amendment was adopted by unanimous vote of the shareholders and directors taken March 4, 1999.
- 5. <u>Number of Votes Cast.</u> Cynthia Taylor, as sole shareholder, voted all of her outstanding shares of stock in favor of the Amendment. Thus, the vote was unanimous.
