The Articles of Incorporation are hereby amended to provide that the name of the corporation is changed to G&F Fritch, Inc.

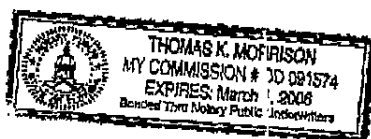
3. The foregoing amendment was adopted by the Shareholders and Directors of the Corporation on October 22, 2003.
4. The amendment was approved by the shareholders with the number of votes cast being sufficient for approval.


