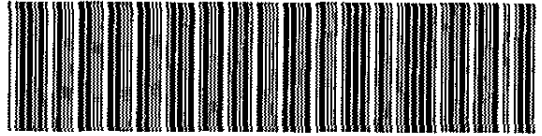

RESOLVED, that the Articles of Incorporation be amended by changing the name of the corporation, substituting the following new Article I:

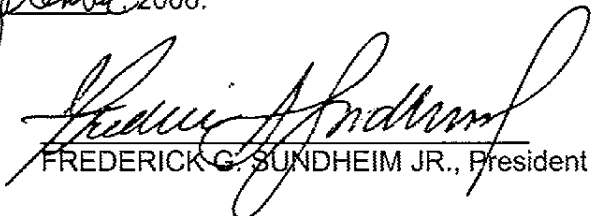
ARTICLE I
