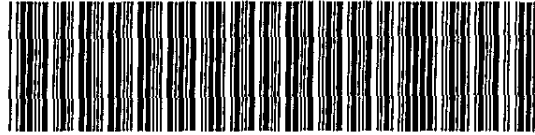



The undersigned hereby certifies as follows that:

1. Vivienne K. Colver, Inc. ("Corporation"), was incorporated under the laws of the State of Florida effective May 25, 1983, by document number G41096;
2. By special meeting conducted October 25, 2004, dissolution of the Corporation was authorized and approved by the sole shareholder of the Corporation;
