

As per our conversation on November 17, 2000 at 1:30 pm, I am sending you the pertinent documents and explanation as to why our 2000 UBR was not filed.

On, June 7, 2000, I spoke to Maria at the Division of Corporations as we realized that we had not filed our 2000 UBR or in fact had ever received the form. Maria instructed me to submit a letter stating we did not receive our original filing form in January, because our business had moved. Along with this letter we were to send in a check for \$150.00 and the late fees would be waived. Maria also gave me instructions on how to order a blank form to complete with the correct information.

I followed Maria's instructions and on June 9 mailed the three documents requested.

On or about July 11 we received a 2000 UBR, forwarded to our correct address by the post office, (copy enclosed). This mailing was never addressed because we assumed the June 9 correspondence was being processed.

On or about July 20 we received a letter, (copy enclosed), that our report had not been filed and there was a balance due of \$400.00. When we called the Division of Corporations, we were told by Brian that late fees are never waived and our corporation was dissolved and we needed to send in \$750.00.

Unfortunately, the office personnel who made this call to Brian was not me, as I was on vacation. So, she decided to wait for me to return.

On or about September 19 I did in fact call Brian. He was adamant about the fact that our corporation had been dissolved because the late fees were never received and we needed to submit an application for reinstatement along with the appropriate fee of \$750.00.

On or about November 1 the reinstatement form arrived, since it also had to be forwarded to us by the post office, (copy enclosed).

Which again prompted my call to you, Ms. Prather. You stated that the late fees would in fact be waived and the report would be filed. It would be greatly appreciated if when this has been done I could receive notification as I am anxiously waiting for this matter to be properly handled.
