ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FAMILY HEALTH CARE OF CENTRAL FLORIDA, P.A

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida professional service corporation hereby adopts these Articles of Amendment to its Articles of Incorporation:

ARTICLE 1 - NAME

The name of the corporation is Family Health Care of Central Florida, P.A. (hereinafter referred to as the "Corporation").

ARTICLE II - ADOPTION AND TEXT OF AMENDMENT

The sole Shareholder and Director of the Corporation approved resolutions amending Article I of the Articles of Incorporation by Joint Written Consent dated

"ARTICLE I - NAME OF CORPORATION

The name of this corporation is FHC Legacy, P.A."

FURTHER RESOLVED, that corporate counsel is authorized and directed to file the aforesaid Articles of Amendment with the Division

of Corporations of the Florida Department of State, a certified copy to then be placed in front of the Corporation's minute book, directly preceding the Articles of Incorporation, with a copy to also be affixed to this Consent; and

FURTHER RESOLVED, that a new stock certificate will be issued by the Corporation's Secretary to the sole Shareholder to reflect the above name change."
