To whom it may concern.

Today I spoke to Amy Alan in your Reinstatement Division about my personal situation affecting my company Having Babies After 30 Inc. (date incorporated 6/27/1983 - FEI number 59-2248618, Document # G46296).

On August 18, 1997 my stepfather died of terminal liver and kidney cancer; the cancer was diagnosed 2 weeks prior to his death. He left behind my 85 year old mother who was in shock at the suddenness of his death and subsequently experienced a severe grief reaction. I am her only daughter and I live 1 hour away from my mother. My corporation only has one employee and that is me. My position is Executive Director. I am a very small company and when I don't actively work, my company does not function. I took off a 10-week family leave from my business as allowed by the Family Leave Bill signed by President Clinton to take care of my mother during this difficult transition.

Therefore, I request immediate reinstatement as an S-corporation based on my personal Situation. Ms. Alan told me I should send this letter along with the reinstatement form and \$165.00 to cover the annual report costs.
