- 1. The name of the corporation is LIFETIME OF VACATIONS MANAGEMENT CO., INC. (the "Corporation").
- 2. The Corporation was formed in the State of Florida on June 28, 1983, under Charter No. G46446.
- 3. A majority of the shareholders of the Corporation entitled to vote authorized the dissolution of the Corporation pursuant to an Action by Written Consent of Shareholders Without Meeting dated December 20, 1996, in accordance with Section 607.1402 of the Florida Business Corporation Act, and such number cast for the dissolution was sufficient for approval.
