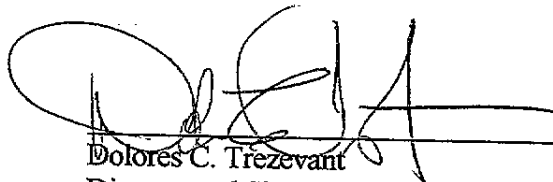

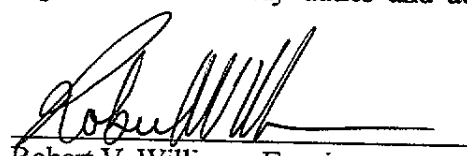
1. The name of the corporation is **Bradley Engraved Stationery Co.** The date of incorporation was June 30, 1983, evidenced by Document No. G46908.
