Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.


FIRST: Amendments adopted: The following Articles shall be amended to read as follows:

ARTICLE I. NAME The name of this Corporation shall be amended. The current name, The Robb Report of South Florida, Inc. shall no longer be the name of the Corporation. The new name shall be Prestige Media Ltd., Inc.

SECOND: The date of each amendment's adoption shall be August 31, 1999.

THIRD: Adoption of the Amendments - The amendments were approved by the sole shareholder of the Corporation. The number of votes cast for the amendments were sufficient for approval.
