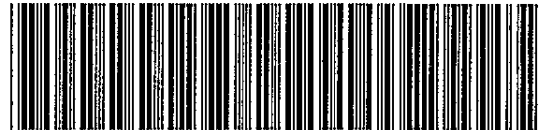

**FIRST:** The following Article I is hereby amended to read as follows:

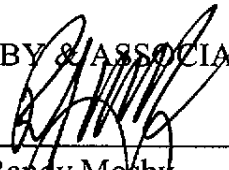

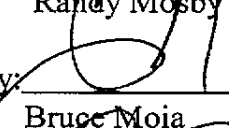
The name of the corporation is **MOSBY, MOIA, BOWLES & ASSOCIATES, INC.**
