THIS CAUSE coming to be heard ex-parte upon the Plaintiff's request for a replacement custodian, the parties having consented to the appointment of G. Thomas Brooks, III, as the replacement custodian, the Court having being otherwise advised in the premises, it is;

## ORDERED AND ADJUDGED as follows:

- The Court finds that the Plaintiff is entitled to the appointment of a replacement custodian pursuant to the provisions of Florida Statute 607.1434 for the corporation LSLT Churchwell, Inc.
- 2. G. Thomas Brooks, III, is qualified to act as Custodian of the corporation.
