**ORDER APPOINTING REPLACEMENT CUSTODIAN**

THIS CAUSE coming to be heard ex-parte upon the Plaintiff's request for a replacement custodian, the parties having consented to the appointment of G. Thomas Brooks, III, as the replacement custodian, the Court having being otherwise advised in the premises, it is;

ORDERED AND ADJUDGED as follows:

1. The Court finds that the Plaintiff is entitled to the appointment of a replacement custodian pursuant to the provisions of Florida Statute 607.1434 for the corporation LSLT Churchwell, Inc.
2. G. Thomas Brooks, III, is qualified to act as Custodian of the corporation.
3. The Custodian shall be entitled to such compensation for his services to be paid from the assets of the corporation from time to time.
4. The Custodian is hereby granted the following powers, obligations, duties and such other powers, obligations and duties as the Court may grant or impose upon the Custodian from time to time during the term of the custodianship:
  - A. To take possession and control of the property of the corporation and continue its day to day operations.

- B. To receive all receipts generated by the corporation now and to be generated by the corporation during the term of the custodianship.
- C. To enter into such agreements and contracts of whatever kind or nature as may be necessary for the maintenance and preservation of the corporation's assets.
- D. All checks for the payment of expenses for the corporation shall be executed solely by the Custodian. Custodian shall have the right to hire and fire employees as he deems necessary in order to carry out the business of the corporation.
- E. To retain counsel or a CPA.
- F. File with the Court, with copies to all parties to this action, a monthly report of custodian's activities, including all receipts and disbursements, such reports be filed during the pendency of this action or until further order of this Court.
- G. Open and maintain such bank accounts as the Custodian may deem necessary for the performance of Custodian's duties.
