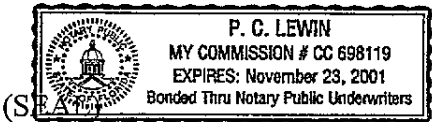

WHEREAS, it is in the best interests of the corporation to dissolve the corporation.

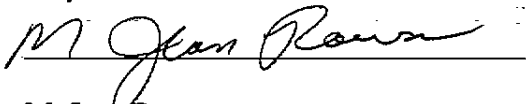
NOW THEREFORE, IT IS HEREBY RESOLVED:
