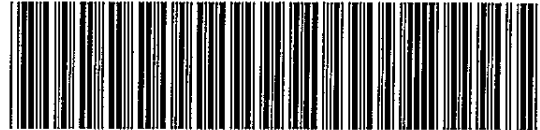

**FIRST:** The name of the corporation is: GAPPA, Inc., a Florida corporation. The corporation was incorporated on August 29, 1983.

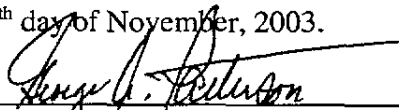
**SECOND:** The date dissolution was authorized: November 25, 2003.

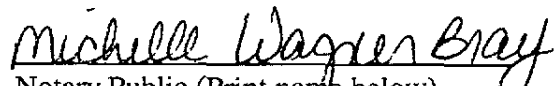

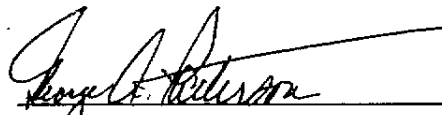
