Pursuant to the provisions of Section 607.1003 and Section 607.1006 of the Florida Business Corporation Act, **FALK, WAAS, HERNANDEZ, CORTINA, SOLOMON & BONNER, P.A.**, a Florida professional service corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is **FALK, WAAS, HERNANDEZ, CORTINA, SOLOMON & BONNER, P.A.** The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on August 29, 1983 and Articles of Amendment to the Articles of Incorporation were filed on January 11, 2006.

Effective Date


The effective date of the Articles of Amendment to the Articles of Incorporation is January 1, 2019.
