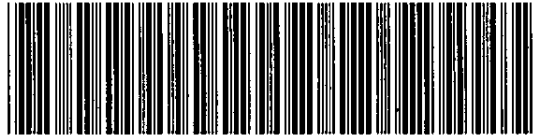



Pursuant to Section 607.1006 of the Florida Statutes, SPECIAL BEGINNINGS BIRTH & GYNECOLOGY CENTER, INC. (the "Corporation"), a corporation organized and existing under the laws of the State of Florida, under Document Number G60154, filed in the office of the Secretary of State on September 9, 1984, certifies as follows:

1. The directors and shareholders of the Corporation considered amending the Articles of Incorporation in order to change the name, and after discussion, it was

RESOLVED, that the Articles of Incorporation of SPECIAL BEGINNINGS BIRTH & GYNECOLOGY CENTER, INC. be amended to change the name from SPECIAL BEGINNINGS BIRTH & GYNECOLOGY CENTER, INC. to SUNFLOWER LIGHT MANAGING AND PUBLISHING COMPANY, INC., and that Article I shall be amended to read in its entirety as follows:

"ARTICLE I - NAME OF CORPORATION

The name of the corporation shall be
SUNFLOWER LIGHT MANAGING AND PUBLISHING COM-
PANY, INC."

2. These Articles of Amendment were approved by the sole director of the Corporation and by the shareholder of the Corporation by joint written action dated March 1, 2008, which is sufficient for approval.
