1. The name of this corporation is **BRIDGESTAR, INC.**
2. Articles of Amendment to the Articles of Incorporation of **BRIDGESTAR, INC.** were duly and unanimously adopted by both the board of directors and by the stockholders of **BRIDGESTAR, INC.** on September 20, 2008.
3. The amendment so adopted was to amend Article V of the Articles of Incorporation of **BRIDGESTAR, INC.**, to change the number of directors of **BRIDGESTAR, INC.** so that Article V provides in its entirety upon such amendment, as follows:

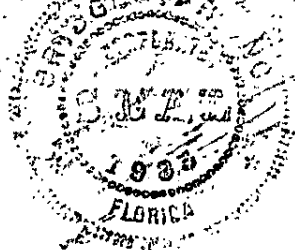

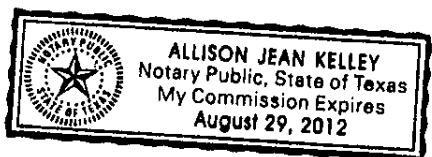

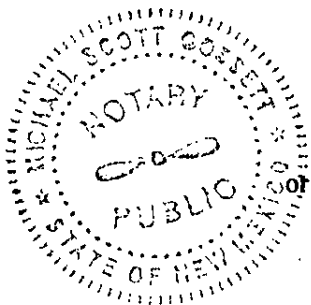
