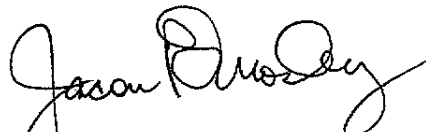

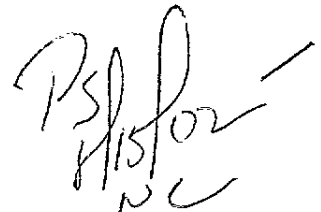

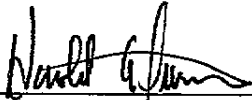
Article I of the Articles of Incorporation of Jemco of Pensacola, Inc. is hereby amended to read:

IN WITNESS WHEREOF, the undersigned President and Secretary of this corporation have executed these Articles of Amendment this 1st day of August, 2002.



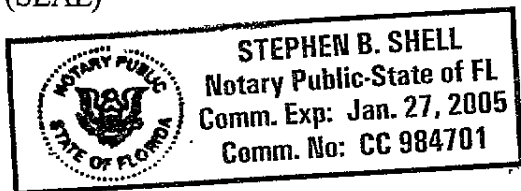

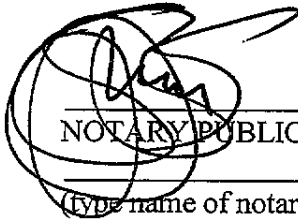
