Recently I received a "second notice" for the above mentioned corporations for which I file the corporate reports. I am at a loss to understand what has occurred. I have researched my records and my records indicate that checks were issued on April 15th of this year (check #1055 for FLEP, and #1056 for RHT), but they are not yet returned. I just queried the 850-488-9000 number to verify the status, and the reports have not yet been processed. I can only guess that they were lost or destroyed in the mail or related handling process.

These companies are very small sub S corps, and additional expenditures would cause hardship. In fact RHT is inactive and is only being kept alive to pursue a lawsuit against a former partner who purloined commissions, the company business accounts, and assets. The legal process has been ongoing since '96 and the defendant has utilized bankruptcy protection as a defense, and to default. Further expenses for this company only add insult to injury.


I assert that the Annual Reports for both corporations were completed, checks issued, and that both complete packets were sent on a timely basis to your offices on or about April 15, 1999.

Your decision to process the accompanying replacement forms and checks, and to allow the 1st notice fee schedule would be greatly appreciated.

I have just ordered a stop payment for checks #1055 and #1056, and will request a copy of the stop payment if you require evidence of same.
