THE UNDERSIGNED, Henry Levine, M.D., President of GASTROENTEROLOGY ASSOCIATES OF CENTRAL FLORIDA, P.A. - HENRY LEVINE, M.D. & PHILIP N. STYNE, M.D., a Florida professional service corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is GASTROENTEROLOGY ASSOCIATES OF CENTRAL FLORIDA, P.A. - HENRY LEVINE, M.D. PHILIP N. STYNE, M.D.

ARTICLE SECOND: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Articles of Incorporation is amended to provide as follows:
