ARTICLES OF INCORPORATION OF

THE UNDERSIGNED, Henry Levine, M.D., President of GASTROENTEROLOGY ASSOCIATES OF CENTRAL FLORIDA, P.A. - HENRY LEVINE, M.D. & PHILIP N. STYNE, M.D., a Florida professional service corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is GASTROENTEROLOGY ASSOCIATES OF CENTRAL FLORIDA, P.A. - HENRY LEVINE, M.D. & PHILIP N. STYNE, M.D.

ARTICLE SECOND: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Articles of Incorporation is amended to provide as follows:

ARTICLE I - NAME

The name of this corporation shall be GASTROENTEROLOGY ASSOCIATES OF CENTRAL FLORIDA, P.A.

ARTICLE THIRD: The Amendment to the Articles of Incorporation of the Corporation reflected in ARTICLE SECOND hereof was duly adopted by the shareholders and Board of Directors of the corporation by unanimous written consent, executed on April 16, 1997, in accordance with Section 607.0704 of the Florida General Corporation Act.

ARTICLE FOURTH: The effective date of these Articles of Amendment shall be upon the filing thereof with the Florida Department of State.

ARTICLE FIFTH: The Amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE IX as set forth below is added to the current Articles of Incorporation.

ARTICLE IX - DEADLOCKS

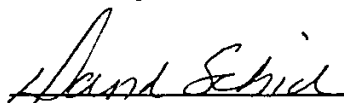
In the event an issue to be decided by the Shareholders is required by the Articles of Incorporation, by the bylaws, by contract, by a Stock Purchase and Shareholders' Agreement or otherwise, to be determined by at least a majority vote of the Shareholders, and at the time such issue is being decided there are an even number of Shareholders, and a majority vote cannot be obtained because the Shareholders are deadlocked on such issue, then Henry Levine, M.D. shall have an extra vote to break the deadlock.

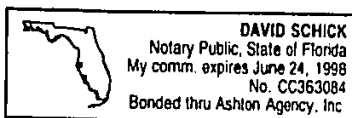
