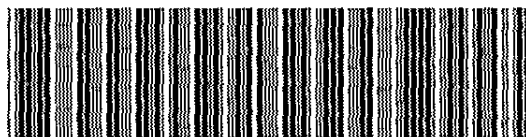



ARTICLES OF AMENDMENT TO ARTICLES OF
INCORPORATION OF INTERARCH DESIGN INCORPORATED

Interarch Design Incorporated, a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

ARTICLE I

The name of the corporation is:
