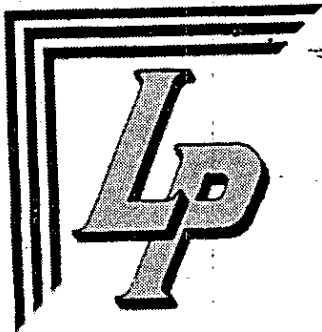


We did not receive the 2002 Uniform Business Report (UBR) Document #G64353.
