I believe that we did not receive a notice From the Florida Department of State/Division of Corporations about ~~filing~~ our Corporate report by May 1st of 2003. One of the reasons I believe this is true is because we had just filed a corporate of report on August 15, 2002. I did receive, however, the notice to file the report with the deadline of September 10, 2003. And I noticed the \$600 late fee if not filed by that date.
