Enclosed is my check for \$165.00 pursuant to the advice of your staff person who suggested that you would consider my dilemma, but I will forward very quickly the \$385.00 penalty if you determine my first form could not have been missed in your mailout. I am anxious to meet all of my obligations before resuming travel in order to easily meet your next deadline of September 17. I will follow your directions promptly. Thank you very much for your consideration.
