I have been nursemaid to my husband for about 10 months now with him being in and out of hospitals with a liver disease that is incurable. Life has not been the easiest in the last 10-11 months as he gets very disoriented. He had contacted Hepatitis C as a result of blood transfusions that he had received at the VA hospital in the late 80's.

He was not diagnosed early enough to get the proper treatment at the time as he had never been a drinker or a smoker nor a drug user (these are the most common reason for hep C) and Hepatitis C was not a common disease at the time.

Because of proper diet and exercise he has lived longer than was expected. However, it appears we are in the last days. With trying to run a business, looking after his medical condition, going back and forth to the hospital, giving insulin, taking his blood, cooking from scratch, (as he is not allowed any processed foods), it has really taken most of my time and planning.
