I am writing this letter to Reinstate the Pelham Real Estate Co. Corporation Papers.

Sorry, but I did not receive the renewal notice for 2003, 2004 or 2005.

It was during the last of 2002 that my husband of 47 years was diagnosed with a terminal disease and it required me to move my business to my home to take care of him 24/7.

We had 11 hospital stays and 5 ambulance runs during this time. There was no time to think of anything else. Thirty (30) days after my husband died, my baby sister whom I had raised, passed away with an aneurysm. This took place in Alabama and since I had her Power of Attorney, I had to sign the papers to remove the Life Support System since she was brain dead.

In the early 90's, my husband had bleeding ulcers for which he received blood transfusion that had not been tested for hepatitis C. Since we have never been drinkers or smokers, it took the Doctors too long to discover the problem and by that time it was too late.

The combination of the 2 deaths took its' toll on me not only emotionally, but physically as I was his only care taker and like a parent to my sister.
