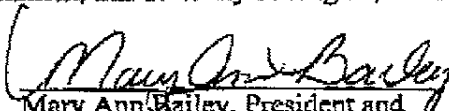

2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

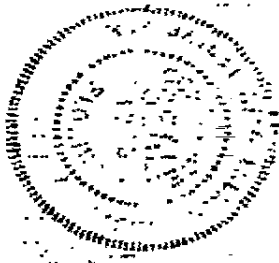
The name of this corporation is: LINE DRIVE ENTERPRISES, INC.
