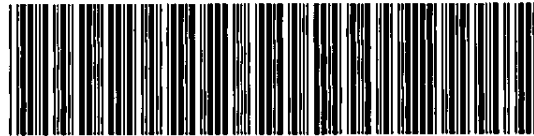

Please note that we have RETAINED your \$105.00 payment.

CAPLIN AND GOBER D.D.S., P.A. is already a corporation. To change from a professional service corporation to a regular corporation, all it has to do is file a CORPORATION AMENDMENT. The amendment would state that the corporation is no longer going to be a professional service corporation, and state the new name -- with the regular corporate suffix -- that the corporation will use.

Or instead of just an amendment, the corporation could file AMENDED AND RESTATED ARTICLES OF INCORPORATION, which would include the same information. Either way, the filing fee would only TOTAL \$35.00.

The conversion laws are used when an entity wishes to transform itself into a different kind of business entity, or when it wishes to change the jurisdiction under which it is formed.

When CAPLIN AND GOBER D.D.S., P.A. becomes a regular corporation it will retain its present Florida Document Number -- G68492 -- and will still be required to file a 2010 Annual Report.

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION  
OF  
CAPLIN AND GOBER D.D.S., P.A.**

**FIRST.** The Articles of Incorporation (the "Articles") of CAPLIN AND GOBER D.D.S., P.A., a Florida professional service corporation (the "Company"), are hereby amended to convert the Company from a Florida professional service corporation established under and pursuant to Chapter 621, Florida Statutes, the "Professional Service Corporation and Limited Liability Company Act", into a Florida business corporation established under and pursuant to Chapter 607, Florida Statutes, the "Florida Business Corporation Act".

**SECOND.** The Articles of Incorporation of the Company were filed with the Florida Department of State on November 9, 1983.

**THIRD.** Article I. is hereby deleted in its entirety and replaced with the following:

**Article I- NAME**

The name of this corporation is: **CAPLIN AND GOBER D.D.S., INC.**

**FOURTH.** Article II is hereby deleted in its entirety and replaced with the following:

**Article II- PURPOSE**

The general nature of the business to be transacted by this corporation is to conduct any and all lawful activities or business permitted under the laws of the United States of America and the State of Florida, (and in particular,

without limitation, Chapter 607, Florida Statutes, (the "Florida Business Corporation Act").

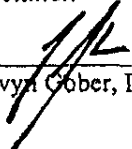
**FIFTH.** All of the provisions of the Articles not amended herein are hereby ratified, confirmed and shall remain unchanged.

**SIXTH.** These Articles of Amendment were adopted by the unanimous joint written consent of all of the shareholders and all of the directors of the Company, effective as of April 1, 2010, and the number of votes cast for the amendments by the shareholders was sufficient for approval.

**IN WITNESS WHEREOF,** the undersigned and duly authorized officer of the Company has executed these Articles of Amendment to the Articles of Incorporation as of this 26 day of March, 2010.
